In-house License Agreement for Cesys UDK Software

§ 1 General and Definitions

- § 1.1 CESYS Gesellschaft für angewandte Mikroelektronik mbH, Zeppelinstrasse 6A, D-91074 Herzogenaurach ("CESYS") is willing to license the software program package ("*Software*") to the "licensee" only if you accept all of the terms in this license agreement. If you do not agree to this terms, CESYS will not license the *Software* to you, and you immediately have to delete all copies of the software you have in any form.
- § 1.2 CESYS grants Licensee and to third parties acting on behalf of Licensee, as an individual or a legal entity, a non-exclusive worldwide royalty free, perpetual license to use the *Software* according to the terms and conditions defined below.
- § 1.3 The "Software" covered by this agreement consists of:

The binaries and the source-code that is delivered with the CESYS-products PCleV4BASE (C1080–3807), EFM01 (C1050-4107), EFM02 (C028229, C028239, C028240), USBV4F (C1030-4007) and PCIS3BASE (C1010-3105) and is marked as "Copyright CESYS GmbH" or similar. In detail: PC driver, API, Firmware, FPGA sample design, cesys-TestBench, cesys-Monitor, cesys-Lab, UDK3 board manager and UDK3 performance monitor. Parts of the software is covered by other licenses like Linux GPL or PLX license. Cesys does not claim any copyrights on 3-rd party software. Only Software that is marked as copyright by Cesys is covered by this agreement.

§ 2 Copyright and Ownership

CESYS is and remains the sole and exclusive owner of the Software.

Besides the rights to use the *Software* as defined by this license agreement, you receive no further rights concerning this *Software*. Licensee shall be the sole and exclusive owner of modifications, derivatives, compilations or applications of the Software developed by or on behalf of Licensee.

§ 3 Use of the software

The licensee may modify and compile the *Software* and use, sell, export and distribute the resulting binaries freely as he likes worldwide. He may use the *Software* as a guide to design own products. He may not distribute the source code in whole - or parts of it - nor make it available to third parties, except with respect to third parties acting solely on behalf of Licensee.

§ 4 Product Updates

CESYS reserves the right to modify and enhance the *Software* in the pursuit of engineering progress. CESYS may change and/or update the contents and implementations of its products at any time without prior notice. CESYS has no obligation to update the software. The licensee will get the latest update of the *Software* and the license granted under Section 1.2 with respect to such updates of the software for a time span of 1 year from when this contract was signed.

§ 5 Limited Warranty and Liability

- § 5.1 CESYS does not warrant the suitability of the Software for any purpose.
- § 5.2 The Software comes as it is.

§ 5.3 In no event shall CESYS be liable for any direct or indirect damages (including, but not limited to loss of data, loss of profit or business interruption) arising in any way out of the use of this software.

§ 6 Termination of the License Agreement

- § 6.1 If the licensee or any third party acting on behalf of Licensee are in breach of any of the terms of this license agreement, CESYS may cancel this contract upon 10 days notice to Licensee. After the cancellation of the agreement, Licensee and third parties acting on behalf of Licensee are not permitted to continue to use the Software, either in whole or in part.
- § 6.2 In case of any termination of the agreement, Licensee is obliged to return to CESYS the Software within 10 days of notification of such termination as well as all working and backup copies or to destroy them.

§ 7 Miscellaneous

- § 7.1 Licensee is not permitted to transfer or assign Licensee's rights and duties arising from this license agreement to a third party without written approval of CESYS.
- § 7.2 This agreement is governed by the laws of the Federal Republic of Germany. The place of jurisdiction shall be Nürnberg (Germany).
- § 7.3 Should any provision of this license agreement be held to be invalid by any court or competent jurisdiction, that provision will be enforced to the maximum extend permissible, and the remainder of the license agreement shall nonetheless remain in full force and effect.
